

## Data Protection Info

Dear client,

ahead some informations how I'm treating your personal data.

### 1.) How I will use your data and all data you pass me from third parties?

I will use all your data and all data you pass me from third parties exclusively for our business relationship, and sending you informations about my professional services!

### 2.) The time your data and all data you pass me from third parties will be in my system

All data you provide me, are recorded on paper and on my computer system (backup on „icloud“ with double security code) for the time lasting of our comercial relationship, which in most cases will end with the last payment from you, or the day after the end of your event. All data needed for: A legal business relationship, the service contract between you and me, and the invoices, will be recorded as long as the local authorities (tax office, social security etc.) are asking for - at the moment for 5 years!

All data not needed anymore for our business relationship will be deleted from my system, and all papers will be destroyed immediately after not being needed anymore for our business relationship, a part from the data needed for the local authorities (see before), these will be deleted in January 5 years after the year of your event. But: I will save your name and contact details (telephone & email) for future Info-Mailings about my services, as I allow you also to save my data for future business as well. Please let me know by e-mail, in case you want me to delete all your data from my database, and that you don't want to receive anymore mails or infos from me.

### 3.) To whom I pass your data and all data you pass me from third parties?

To give you the best, and also a 100% legal service, I will pass these data to:

- o The artists you have contracted through me - therefor you will know the person/s
- o Third party providers you have contracted through me - therefor you will know the person/s or company
- o My employees Carmen & Karim, who help me to make your event entertainment a big success
- o All local authorities, that are asking for your data (tax office, town hall, social security, police etc.)
- o My solicitors, who are in charge to prepare my tax declarations and send all legally needed reports to the local authorities. Please let us know, if you want to know who they are, and I will tell them know to get in touch with you. By the way: They are speaking Spanish and Catalan, and only a little bit English!
- o All persons and companies you ask me to pass on your details for a better communication during the production of your event entertainment.

All persons/companies mentioned before will receive this info-paper, to know about my way how I treat your data. By accepting a service for you all theses collaborators are accepting my data protection rules, and know what to do to full fill them the same way as I do.
